The regular monthly meeting of Ambler Borough Council was held Monday, June 18, 2007 at 8:00 p.m. in Borough Council Chambers located at 122 E. Butler Avenue. President Anita O'Hara Pieri presided.

Mr. Lou Orehek led the public in the Pledge of Allegiance and a moment of silence.

He noted that while signed petitions had been mentioned by two members of the public against Ordinance 1007 (Sign Ordinance) neither Borough Council nor the Borough Manager had received these petitions. Mr. Sal Pasceri's motion to approve the Minutes, as amended, was seconded, carried.

Mrs. O'Hara Pieri read into the record a letter she had received from George Benigno, Secretary of the Planning Commission, stating that the Commission had not been worn down by Council regarding approval of the Sign Ordinance, and that the Commission in fact affirmed and recommended approval of the Ordinance.

Mrs. O'Hara Pieri then noted that Mrs. Baigis had publicly stated that one of the Planning Commission members who registered a vote on the Sign Ordinance had at one time worked for Ambler Savings & Loan and that at that time Mrs. Baigis had asked whether this created a conflict of interest for that member. Solicitor Bresnan's advice was sought, wherein he stated that he would write an opinion letter to Council after his review of State ethics guidelines on potential conflict when casting a vote. He did state that it was appropriate to point out that a relationship exists/existed and that the question to be asked was whether this relationship precludes voting on an issue.
