## MINUTES AMBLER BOROUGH COUNCIL REORGANIZATIONAL MEETING

JANUARY 7, 2008 7:00 P.M.

The 2008 Reorganizational Meeting of Ambler Borough Council was held January 7, 2008 at 7:00 p.m. at Ambler Borough Hall, 122 E Butler Avenue, Ambler, PA 19002. Mayor Wahl presided.

Certificates of Election were validated by Mayor Wahl. It was determined that although Mary Maxion had misplaced her certificate, she would be sworn in by the Mayor. Mayor Wahl directed Ms. Maxion to produce her certificate at a future date. Mayor Wahl then proceeded to administer oaths of office to Peter Amento, Tony Isabella, Mary Maxion, Salvatore Pasceri and Anita Pieri.

Mayor Wahl then reviewed procedures for election of Council President and Council Vice President with Council. Council, by show of hand, elected to nominate all candidates for president before casting a vote, and then to nominate all candidates for vice president before casting a vote. Council also elected to have votes recorded.

Nominated for President were Tony Isabella and Tom Kenney. Vote tally: Isabella – 5 Aye (S. Pasceri, Isabella, Dooley, G. Pasceri, Amento); Kenney – 4 Aye (Maxion, Pieri, Kenney, Baigis). Mr. Isabella was elected Council President. Nominated for Vice President were Paul Dooley and Tom Kenney. Vote tally: Dooley – 5 Aye (S. Pasceri, Isabella, Dooley, G. Pasceri, Amento); Kenney – 4 Aye (Maxion, Pieri, Kenney, Baigis). Mr. Dooley was elected Council Vice President.
