AMBLER BOROUGH COUNCIL MINUTES

August 18, 2009

The regular monthly meeting of Ambler Borough Council was held Tuesday, August 18, 2009 at 7:00 p.m. in Borough Council Chambers located at 122 E. Butler Avenue, Ambler, Pennsylvania 19002. President Tony Isabella presided.

Mrs. Baigis led the public in the Pledge of Allegiance and a moment of silence.

A motion was made to approve the July 21, 2009 Minutes with suggested revisions. Seconded. Carried.

Ambler Borough received funding for revitalization projects from the Montgomery County Revitalization Program, with a check presented for \$249,000 by County Commissioners James Matthews and Joseph Hoeffel. Commissioner Matthews stated that each year for the past nine years the county has contributed \$5 million to municipalities for revitalization projects. Ambler Borough's funds will be used to finance a variety of projects, including reconfiguring the Lindenwold Ave parking lot, landscaping and lighting improvements, façade improvements and renovations at the Ambler Theatre.

The Committee will recommend the following:

- 1. Recommend that the **July** invoices in the amount of **\$422,336.88** be paid as follows: General (\$52,515.40); Street Lights (\$4,699.73); Fire (\$0.00); Parks & Rec. (\$0.00); Water (\$4,626.80); Sewer (\$1,335.33); WWTP (\$24,830.78); Rail Corridor (\$0.00); Road Overlay (\$0.00); Debt Fund (\$0.00); Water Capital (\$0.00); Liquid Fuels (\$13,877.66); with end of month cycle totaling \$101,885.70, voided checks totaling \$0.00 and July bills totaling \$320,451.18.
- 2. Recommend continued participation in the Classic Town program, with \$2,500 fee due in September
- 3. Recommend designating areas in the downtown for local businesses to be eligible to receive façade improvement matching grant monies from the County.

Discussion ensued. Mrs. Baigis asked whether the designated areas could be expanded to include more businesses. Mrs. Aversa responded that revitalization efforts are concentrated in the downtown area.

4. Recommend approval of the Finore 2-lot subdivision (132-134 Mattison Ave.) and the Finore 3-lot subdivision at 155-159 Rosemary, with the Countys' letter, the Borough Planning Commission letter and the Engineer's letter having been received for each application.

In Other Business:

- 1. A public hearing was held to accept public comment on **Ordinance 1040** placing the Sign Ordinance back in the Zoning Ordinance. The Ordinance was adopted 9-Aye.
- 2. **Ordinance 1043** regarding the 2009 Bond project which authorizes staff to execute bond documents when savings exceed \$95,000 was adopted. 9-Aye.
- 3. **Resolution 2009-11** was adopted on August 11, 2009 authorizing the submittal of a \$250,000 PA Conservation Grant request for solar panels to be installed at the Borough Garage. Grant application request remittance of a \$2,000 fee for application preparation and \$8,000 consultant's fee if the grant is approved. A determination on ownership of energy credits will be made within 90 days.
