AMBLER BOROUGH COUNCIL MINUTES

July 21, 2009

The regular monthly meeting of Ambler Borough Council was held Tuesday, July 21, 2009 at 6:30 p.m. in Borough Council Chambers located at 122 E. Butler Avenue, Ambler, Pennsylvania 19002. President Tony Isabella presided.

Mayor Wahl led the public in the Pledge of Allegiance and a moment of silence.

Roll Call – Present: Mr. Isabella, Mr. Kenney, Mrs. Pieri, Mrs. Baigis, Mr. S. Pasceri, Mr. Amento, Ms. Maxion and Mrs. Strus. Mayor Wahl, Chief Foley, Solicitor Bresnan and Mrs. Aversa also were present. Absent: Mr. G. Pasceri.

A motion was made to approve the June 16, 2009 Minutes with suggested revisions. Seconded. Carried.

COMMITTEE REPORTS

Public Safety Committee – Mr. G. Pasceri, Chairman

Committee members: Mr. G. Pasceri, Mr. Kenney and Ms. Maxion

The Committee met on Tuesday, July 7, 2009 at 7:00 p.m. in Borough Council Chambers located at 122 E. Butler Ave. Present: Mr. Isabella, Mr. G. Pasceri, Mrs. Pieri, Mrs. Baigis, Mr. S. Pasceri, Mr. Amento, Ms. Maxion and Mrs. Strus. Also present: Mayor Wahl, Chief Bill Foley, Solicitor Bresnan and Mrs. Aversa. Absent: Mr. Kenney.

The Public Safety Committee report was given this evening by Ms. Maxion.

The Committee will recommend the following:

1. Recommend adoption of **Ordinance 1042** addressing Leaf Waste Recycling in accordance with the request of the NMCRC. [A Public Hearing was held.]

Discussion ensued. Mrs. Aversa stated that the ordinance would apply to leaf waste only and not include branch material or grass clippings. She stated that the Borough was considering once-a-month pickup of yard waste.

2. Recommend adoption of **Ordinance 1041** authorizing the placement of stop signs on Ridge Avenue and Belmont Avenue intersection, North and South, and Reiff's Mill Road and Tennis Avenue intersection, North. [A Public Hearing was held.]

Discussion ensued. Chief Foley explained that his department had thought the placement of these stop signs was already supported by Ordinance and registered with PennDOT, addressing Mrs. Baigis' concern that the stop signs had been erected in advance of the passing of an ordinance. Additionally, he stated that citations would be enforceable only after the enactment of the Ordinance.

- 3. Recommend awarding contract to purchase and install security cameras in the Borough Maintenance garage to 3i Protect in the amount of \$4,455.00.
- 4. Recommend addressing Wissahickon Historical Society request for the Borough to donate its World War II air raid siren to the society.

Discussion ensued. Mrs. Aversa noted that the siren is located at the Palladio Building. Further, she advised Council to consider loaning the siren to the Society with the Borough maintaining ownership.

Recommended at Committee Meeting:

- 1. Council voted at the July 7th Committee Meeting to work with Susan Curry to prepare a grant to remedy flooding at Church and Bannockburn and for matching funding for the Knight Park Green Ribbon Trail Connector, including the acquisition of a portion of the property at Church and Main. An appraisal is required. The grant is due July 17. (8-aye)
- 2. Council voted at the July 7th Committee meeting to apply for the stream bank riparian buffer project with the assistance of the EAC and a \$2,700.00 Borough match. (8-aye)

In other business the following was discussed:

1. The Police Department and Fire Company reports for June 2009 were received.

Discussion ensued. Chief Foley, in response to an inquiry from Mrs. Baigis, clarified that officers had made 27 appearances in Magistrate's Court during the month, and not that they had spent 27 full days in Court.

- 2. The June 2009 Public Works and Code Enforcement reports were reviewed.
- 3. Borough employees are making temporary repairs to Borough alleys.

Discussion ensued. Mrs. Aversa stated that the Borough's priority is to repair Boroughowned alleys with surplus blacktop being used to make other alley repairs upon residents' requests.

Mr. Isabella asked if there were comments or questions from Council or the public. Ms. DeLoach of 405 S. Main Street addressed her concern about flood damage and flash

flooding in her neighborhood, which she stated is designated as a flood plain. She asked whether water retention ponds could be constructed and whether neighboring businesses, Conshohocken Steel and Caddick, could assist by using pervious asphalt or additional shrubbery plantings. Mrs. Pieri explained that the problem is upstream, that overdevelopment has increased 100 year flood occurrences during the past 20-30 years, that SEPTA maintains the creek under the bridge, as does Caddick, and she is persistent is trying to find remedies to the situation. Unfortunately, she stated, this is a floodplain. Mrs. Aversa added that PEMA has not been willing to buy out the homeowners because there are too many residents who refuse to sell. Further, Mrs. Aversa stated that in the past several years Upper Dublin has added retention ponds and recently had applied for a grant to study the problem. Ms. Maxion encouraged Ms. DeLoach to attent Upper Dubin Township meetings, to meet with the Borough's Environmental Advisory Council and with Mrs. Pieri. There being no further questions or comments, it was moved the report be accepted as filed. Seconded, carried.

It was announced by Mrs. Aversa that the plaque presentation for Joe Amento to be dedicated at the ballfield would be rescheduled due to "rain out" and scheduling conflict. - 2. The bid for the permanent chemical feed pump was advertised with bid opening scheduled for August.
- 3. Water distribution system flushing (hydrants) is underway and occurs between the hours of 11:00 p.m. and 6:00 a.m.
- 4. The Borough has applied for funding through the Community Development Block Grant Program. Notice was received that the Borough was recommended for funding for sanitary sewer repairs in the amount of \$183,000.00.
- 5. Staff continues to pursue possible grant money for a biogas utilization study.

Discussion ensued. Mrs. Baigis requested that the fund account totals be retotalled to reflect Parks & Rec expenditures listed in the Warrant Report. Mrs. Baigis asked for an explanation of the check written to the DCED for permit for "Smokestack LLC." Mrs. Aversa stated that a resident made the Borough aware that demolition was occurring at the site, and that Code Enforcement investigated and required the owner to obtain a permit. It was then determined that the owner had not complied with the DEP. The DEP was contacted and a permit was obtained from the Borough. The DEP is addressing this issue directly with the property owner.

2. Recommend **advertising** for adoption Ordinance 1040, returning the Sign Ordinance back into the Zoning Ordinance. [County Planning Commission and Ambler Planning Commission review letters have been received.]

Discussion ensued. It was agreed by Council to consider a recommendation for adoption at the August 4, 2009 Committee Meeting.

- 3. Recommend adoption of **Resolution 2009-10** appointing delegates to represent the Borough on the Tax Collection Committee (TCC).
- 4. Recommend executing a Maintenance Agreement with Tustin Mechanical Services for the Borough Building HVAC System at an annual cost of \$2,412.00.
