Lauren and Sara will plan to attend the December 6, 2016, Council meeting to present their Concept Plans and answer any questions. The Planning Commission Members would like to have input from Council on the direction for their proposal to create a park-like, town-square use for this parcel. Many uses have been suggested for the finished space. However, the majority of the ideas are to not create fixed uses/permanent structures, but to encourage open, attractive space where a variety of events and functions can be held and a variety of organizations can utilize the space. The Planning Commissions, both

the County and Ambler, are looking forward to working together to make this project happen. It will be an eye-catching "green space" among the business properties around it and an attractive asset to the Borough and the community.
