Discussion ensued. Ms. Hertz requested that Council consider, as they exist, whether these are the best Committees to serve the Borough or whether Council should expand its parameters to include, for example, an Environment & Sustainability Committee.

**Other Notifications as determined by the Council President:** Discussion ensued. Mr. DeRuosi suggested Council hold Town Hall Meetings once or twice a year to receive public input. He recommended selecting Wednesday, March 14, 2018 for the first 2018 Town Hall Meeting. On another note, Mr. DeRuosi suggested abbreviating 'Recommendations' recitations at Council Meetings by simply listing the Recommendation number and not reiterating the entire Recommendation paragraph previously stated during the Committee Report.

# The business of the Reorganization Meeting concluded and the meeting was adjourned. Mr. DeRuosi then called the Committee Meeting to order.

# **Public Safety Committee:**

- 1. <u>St. Mary's Development:</u> The Borough Engineer provided stormwater plans for the proposed Upper Dublin development. The Borough Engineer, Jim Dougherty of Gilmore Associates, was present. Discussion ensued regarding the adequacy of the plan to protect flood prone areas in Ambler Borough. Council asked the Borough Manager to prepare a letter to Upper Dublin Township regarding the Borough's concerns.
- 2. Public Works & Code Enforcement Reports: Reports were received by Council.

## **Public Utilities Committee:**

1. <u>Ambler Crossings:</u> Applicant has inquired about water connection fees for the development. The project was approved with sewer fees required in the review letter. Council authorized staff and the Borough Solicitor to discuss fees.

# Parks & Recreation Committee:

 <u>EAC Project</u>: Connie Liu, an Upper Dublin High School student, discussed a joint-EAC/school project involving the Ocean Advocacy Campaign as part of the Bow Seat Awareness Contest. Her topic is creating awareness about plastics in the ocean. She will display artwork at the Earth Day Fest on April 21<sup>st</sup>. She hopes to be able to purchase trash/recycling/composting bins for Butler Avenue. Discussion ensued regarding logistics for maintaining these bins. Mary Margaret Monser, EAC Chairperson, stated EAC would consider public awareness and maintenance as the project moves forward. 2. <u>Red Tail Restoration:</u> Red Tail Restoration has submitted a contract offering for 2018. Red Tail has been involved with removing invasive plants at Ambler Borough Park. Discussion ensued. It was agreed that since the contract amount is below the State threshold of approximately \$19,000, and given their knowledge of the park and expertise, this professional service would not be required to go out for bid. However, the Borough Manager was asked to try to obtain additional quotes and the matter will be reviewed at the Council Meeting.

Salary & Personnel Committee: No business was reviewed or discussed.

There being nothing further, Mr. DeRuosi announced the meeting was adjourned.
