## ORDINANCE NO. 1122

AN ORDINANCE AMEDING THE BOROUGH MUNICIPAL EMPLOYEE PENSION FUND ORDINANCE, CODIFIED AT CHAPTER 1, PART 4 OF THE BOROUGH CODIFIED ORDINANCES, TO PROVIDE AN EARLY RETIREMENT OPPORTUNITY FOR QUALIFIED EMPLOYEES WHO RETIRE BETWEEN JANUARY 1, 2022 AND DECEMBER 31, 2022; KEEPING THE REMAINDER OF THE ORDINANCE IN FULL FORCE AND EFFECT; INCLUDING SEVERANCE AND REPEALER CLAUSES; PROVIDING AN EFFECTIVE DATE

Ambler Borough Council does hereby ORDAIN as follows:

Borough ordinance 467, as amended, and as codified in Chapter 1, Part 4 of the Borough Codified Ordinances, is amended as follows:

1. At codified section 1-414, "Eligibility For Retirement", there shall be added thereto a new paragraph "D", as follows:

"An employee who has at least 20 years of service to the Borough; provided, however, that such retirement benefit shall only be available between January 1, 2022 and December 31, 2022 and any qualified employee seeking to elect such retirement benefit must so state in writing, submitted to the Borough Manager, between and including the said dates."

2. At codified section 1-416, "Determination of Pension", there shall be added thereto a new paragraph "E", as follows:

"The monthly pension payable to those employees who elect to retire under the provisions of section 1-414(D), being employees with 20 years of service who retire between January 1, 2022 and December 31, 2022, shall be 40% of the average monthly compensation paid to such employee during the employee's three highest years of earnings.

- 3. The remainder of the pension ordinance remains in full force and effect. Any provision of any existing ordinance that is inconsistent with this provision is, to the extent of such inconsistency, hereby repealed.
- 4. If any portion of this ordinance is found invalid by a court of competent jurisdiction, then such invalid portion shall, to the extent possible, be severed from the remainder, which shall continue in full force and effect.
