AMBLER BOROUGH PLANNING COMMISSION MINUTES OF SEPTEMBER 24, 2024, MEETING

Discussion regarding requesting Council to allow for the Planning Commission to explore incorporating revisions similar to those in the recent Transit Oriented Development Ordinance to the Downtown Commercial district including aesthetics and architectural elements. The members of the Planning Commission discussed the merits of adding some of the recent revisions made to the Transit Oriented Development Ordinance to the Downtown Commercial zoning district. It makes for good planning sense to have consistency in our down town so we discussed adding these same revisions to our commercial district. A motion was made by Carol DiPietro and seconded by Peter Amento to make a formal request to Council to allow the Planning Commission to discuss these revisions. A letter will be prepared to Council.

OLD BUSINESS:

Input is requested on updating the 2013 Borough Comprehensive Plan. The Pennsylvania Municipalities Code suggests that each municipality review and/or update its Comprehensive Plan every ten years. The Borough's previous Plan was adopted in 2001 with a subsequent Plan update completed in 2013. The County Planner prepared a memo for discussion with regard to community involvement. To begin the outreach process, an online community survey will be published and an open house will be scheduled for January, 2025. The survey questions were discussed in detail with input from the Members and the attendees.
